Quiz instructions

The UvA Library strives to provide public access to theses whenever possible by publishing them on [Theses University of Amsterdam](https://theses.uva.nl/) [\(https://theses.uva.nl/\)](https://theses.uva.nl/) and [Scripties van de Nederlandse Universiteiten](http://scripties.ned.ub.rug.nl/) [\(http://scripties.ned.ub.rug.nl/\)](http://scripties.ned.ub.rug.nl/).

The following questions are used to determine whether publishing is allowed and to request your permission for publication. Publishing has no impact on copyright, which remains vested in you as the author. You can always revoke permission for publication at a later date via the Library. Your thesis will then be deleted from the thesis database.

The Library can rescind publication of your thesis if there are compelling reasons to do so (such as copyright infringement).



After submitting the final version of your thesis, you will also be able to submit a separate version that is suitable for publication. Please use this publication-ready version as the basis for answering the questions below, unless the final version itself is already suitable for publication.

The points scored with these questions are not used as an assessment, but only to determine whether your thesis can be published.



Question 1

Copyright

Your thesis must respect copyright vested in others. This means, for instance, that sources must be properly referenced and that you have permission to use (visual) materials that you have not created yourself, for example by virtue of a Creative Commons license.

Question 2

Personal data and company data

If your thesis contains personal data or non-public company data, it may only be published with the explicit consent of the persons or companies involved. No consent is required if personal data has been anonymised and cannot be traced. Sometimes companies give their consent to disclose certain company information provided a specific embargo period has elapsed. You will be able to indicate this later on.

Now that you have granted permission, we need a bit more information before your thesis can be published.



Question 1

Period of publication

Although the library generally prefers to publish a thesis for an indefinite period, you can also arrange to have your thesis automatically removed from the thesis database after seven years.

Regardless of your choice, permission can be revoked at any time, after which your thesis will be deleted from the thesis database.

Question 2

Embargo

Is your thesis subject to an embargo? An embargo means that your thesis may not be published immediately after you submit it, for example, because it uses company data that can only be disclosed after a certain amount of time has elapsed.

You may elect to postpone publication of your thesis for a period of up to 6 years.

Question 4

License

If you wish to allow others to distribute, share and/or edit (parts of) your thesis, this can be arranged with a Creative Commons license.

The CC BY license is the one most commonly used; in addition to reading, sharing, and editing it also authorises commercial use. You can also opt for a license that excludes commercial use. For further information, see <https://creativecommons.org/share-your-work/licensing-considerations/> [\(https://creativecommons.org/share-your-work/licensing-considerations/\)](https://creativecommons.org/share-your-work/licensing-considerations/).

No matter which license you choose, copyright remains vested in you: you can always reuse your own thesis without restriction, also commercially. If you don't opt for a Creative Commons license, others will be allowed to read and cite your thesis, but they will need your permission to distribute or reuse it.

Although the library will remove your thesis from its database at any time upon your request, a CC license cannot be revoked; please be aware that others might continue to distribute your thesis.
